| 8 | <b>Fee approval for the sessions 2022-23 &amp; 2023-24</b> | <ul style="list-style-type: none"> <li>● Management informed the members that, though a fee increase of 15% over the fees of AY 2019-20 was approved for the AY 2020-21, 2021-22 but the management has not increased the approved fees increase of 15%.and the same was charged in 2020-21 as was charged in AY 2019-20.</li> <li>● Considering that the pandemic has had its damaging effect on several families &amp; to enable smooth flow of education the management has considered the request of the parents and has granted a waiver of 25% in the fees for the AY 2020-21.</li> <li>● Further the management has allowed a waiver of 15% equal to approved increase in the fees for the AY 2021-22 and additional 10% fee waiver totalling to 25% fee waiver.</li> <li>● School management has proposed the increase in school fees by 15% over the fees applicable for the AY 2021-22.</li> <li>● The above proposal has been considered by the EPTA, keeping in mind the various factors mentioned in the section 9 of the Maharashtra Educational Institution (Regulation of fees) Act 2011 and on finding the aforesaid proposal to be reasonable, the EPTA has approved the increase of school fees by 15%, over the fees applicable for the AY 2021-22.</li> <li>● These approved fees will be applicable for the academic session 2022-23 &amp; 2023-24.</li> <li>● Though the above increase in fees has been approved by the EPTA, in case of any difficulty in resumption and conduction of physical classes in the school, the management shall consider granting a waiver of 5% in fees.</li> </ul> |
